ESFA AGM 9th July I write this as I prepare to accompany our U18 Boys squad for their opening Centenary Shield game in Belfast. Having joined the squad for their training camp at St George's Park as well as enjoying time with them at Rectory Park for the impressive victory against the RAF and at Shrewsbury School for their fixture with ISFA, I know the team bonding and camaraderie required to be successful are well on their way to being established. I look forward to sharing in their journey in the same way as I do with the girls squad. Unfortunately, due to the timing of my half term I was unable to join the U15 Girls camp at St George's Park in full but was privileged to visit on the Tuesday to present the squad with their England shirts and to welcome them to life as international footballers. I know from my time with them there, as well as at the recent ISFA fixture hosted at Charterhouse School, they too have bonded extremely well and are eagerly anticipating the Bob Docherty Cup.

Away from the international stage, five membership consultation events have recently taken place. I would like to place on record my gratitude to the regional secretaries, CSFA and DSFA representatives for their positive engagement during their three respective events regarding the Champions Cup. The meetings were positive and balanced with all participants ensuring a solution focussed approach throughout. As with almost everything in life we know that it is highly unlikely to reach complete consensus on everything but it is by adopting the approach that these groups have that we are most likely to understand the challenges and opportunities from the viewpoints of all parties and therefore achieve the best and most appropriate outcomes. This week, we have hosted two consultations around our volunteering strategy and some really positive discussions and plans were shared and contributed towards.

I would like to finish this edition's opening statement by welcoming three new post-holders to the ESFA family. John Duncan joins council as our Equality, Diversity and Inclusion co-opted member following a competitive interview process. John joins us with a wealth of relevant experience and I look forward to seeing the impact that I am confident he will have. Secondly, Paul Jackson has been appointed to council representing the South-East region and we look forward to working with him moving forwards. Oz Rowley has been appointed as U15 Girls Assistant Manager following the work-related resignation of Adam Jones just a couple of weeks prior to the training camp. As a valued and committed member of the international trials staff, Oz was able to hit the ground running with the squad and management team and has made a really positive impact already. Oz will continue in the role for the remainder of this season. Having mentioned Adam, it would be remiss of me to not recognise his valuable input and contribution during his time with us. It is a huge shame for him personally that he has not been able to progress to the role of Manager but he can be very proud of all that he contributed as Sian's Assistant.

Report of Council- March 2022

Mark Hignett, Chair for 2021/22, welcomed Council Members to their first face to face meeting for two years and thanked Charterhouse School for hosting the meeting to coincide with the international U15 girls' friendly fixture against ISFA, and the CEO and her staff team for making the arrangements.

Council determined that the ESFA AGM would continue to be held in two parts, with part 1 taking place online on 9th July. Member rule changes would need to be submitted no later than Wednesday 1st June to accommodate the 35 day deadline agreed at the last AGM, as 2nd June was a bank holiday. Further discussions were held about the challenges in securing match officials for schools' football, and Members noted that the CEO had approached The FA to reissue previously sent joint correspondence to CFAs which outlined the support expected for the schools' game. A response was awaited. Members noted that the survey following the latest round of Champions' Cup consultations had been issued, with a response deadline of 25th March. Council Members agreed to take part in a new article in "Membership Matters", called "Spotlight On.." to refresh Membership on the roles and responsibilities of both Council Member and staff, following recent changes.

The Rep Committee considered the arrangements for the forthcoming international fixtures and noted that results and forthcoming fixture details were being published on the <u>ESFA website</u>. An update was also received on the progress of rep football competitions. Consideration was given to the Committee's arrangements for next season, and Members expressed their deep gratitude to Owen Aiston, outgoing Chair of the Committee, for his diligence and commitment to the role.

The Football Governance Committee received an update on applications for sanction and on the ongoing work being undertaken with volunteers on the National Working Group for SCORY. The Chair placed on record his thanks to those contributing to the group. The routine discipline report was received and concern was expressed about the implementation of some aspects of the regulations in the schools' game, with FA interpretation to be sought. The Committee recommended to Council that Members should seek feedback from their constituency about how they administered disciplinary cases, if they did, given the low levels of feedback from the survey. This was approved.

The Football Development Committee received an update on the take up of the Development Fund and had a progress report on the planned summer Disability Festivals. The Committee recommended to Council that the Festivals were named in honour of the late Duke of Edinburgh, former ESFA patrol, and Council approved this, subject to permission from the Palace.

The Competitions Committee heard of the plans for National Finals, with the PlayStation Schools' Cup taking place from 23rd – 26th May at West Bromwich Albion. The FA CEO would attend one final and the FA Chair was aiming to attend another, diary permitting. Other finals were to be confirmed. Members also agreed that consideration should be given to those on decelerated learning programmes and how they could continue to take part in schools' football.



Report of Council- Continued

The Committee recommended that, should the Champions Cups continue, the U15 girls' competition should be introduced next season, so that the current U14 teams could progress. In principle, without predetermining the continuation and/or format for the Champions' Cups, Council approved the recommendation.

On top of matters reported elsewhere, Trustees updated on the appointment of Lloyd Wilson, new Governance Manager and confirmed that the internship scheme had been re-opened following the re-opening of HQ post-pandemic. Trustees had approved the updated risk assessment for HQ and reviewed the policy for match attendance, which remained unchanged for Membership. A detailed report on sponsorships and partnerships had been received, along with feedback from Schools' Football Week. The intra-school football project ("Hot Shots") had been launched and draft contracts for administrator funding had been approved.

Council Members received the report of the ESFA's rep on FA Council, noting that the new FA Chair had agreed to meet with all education partners as part of her induction, at the request of the ESFA's CEO.

ESFA Hotshots

Hotshots is a new initiative created by the ESFA, which is all about intra-school football!

The project's aim is to encourage as many young people as possible into team sport, regardless of ability and we will encourage participating schools to organise intra-school football activity between 14th March 2022 and 27th May 2022. The ESFA is also able to incentivise this activity and each school that signs up and organises intra-schools' football during this period will be entered into a prize draw with the possibility of winning a £3,000 cash prize from their relevant activity category.



Desktop Reviews

Our National Child Welfare Officers continue to conduct their desktop reviews at the same time as the support visits are taking place.

From both the desktop reviews and the safeguarding support visits, the most commonly recurring theme is that parents and players do not always know who to contact in the event of concerns.

One Association has addressed this by making sure their CWO name and contact details feature on every team sheet: others add details to programmes when they are produced.
