PLCF Funding Confirmed

The PLCF has confirmed its continued support of ESFA U11 District Rep football for this season and for next. Although on a reducing funding scale over the two seasons, this is great news given our expectation that continuation funding would not be awarded this year.



The ESFA extends its grateful thanks to PLCF for this grant funding. The awards process is being finalised with PLCF this week and we hope to launch the competitive application for funding in the first part of November. Eligible Associations will be contacted and a general announcement, with guidance, will be published on the ESFA website. We look forward to receiving your applications!

In the meantime, regional tournaments have begun, with SW (West) teams enjoying a fantastic day at Landsdown Playing Fields, in Bath, on 7th October & Districts from the SE enjoying the first of two events for their region, this time at Motspur Park (Fulham FC) on 21st October. The remaining tournaments have been set as outlined here. We are in negotiation with PLCF regarding the date and venue for the national finals.

The FA's National Game Board Conference

Earlier this month, The FA held its National Game Board Conference, where the ESFA was represented by Mike Spinks, Andrea Chilton and Andy Weston. The primary purpose of the conference was to consult on the development of a singular, refreshed strategy for football, in which The FA outlined their desire to "continue to inspire children to love the game". The coming weeks will see several consultation meetings with The FA, during which we will aim to consolidate and enhance our role with them as the major provider of schools' football. There will be many calls on the additional income that the FA has secured from international broadcasting of The FA Cup: positioning schools' football as valuable beneficiary of this will be an important part of these discussions. Last season saw the Association support around 74,000 teams and this significant contribution to football positions us well for these conversations.

From the Noticeboard

- Data Protection: make sure you comply

Data protection regulations are changing in the new year and penalties for breaches of the regulations will be increased. A timely reminder therefore that, if you hold "personal data" – data by which an individual can be identified (name/address/date of birth/contact details) or which is "sensitive" (medical records, for example, or child protection measures) – about your players, coaches, parents and supporters, you must ensure that:

Personal data is held only for "limited, specifically stated purposes": this means, if you ask someone for their personal details, you need to tell them why. Phrases like "Thanks for giving us your details. We'll use them to check your eligibility to play and/or to keep you up to date with our activities" might help when you give players and associates forms to fill in.

Data is not held for longer than necessary: this doesn't mean you can't keep an address book, local records about player achievement or celebratory materials recognising the contribution of volunteers. It does mean that you shouldn't keep information you don't need to have. So, for example, if you have medical records for players long gone from your Association, you should make sure they are confidentially destroyed.

Data is held securely and not shared with third parties without permission: this doesn't necessarily mean locked strong boxes, but it does mean you must only share information with those who need to have it. Make sure any electronic records/devices are securely protected (most phones now require you to "unlock" them, for example, if they've not been used for a minute or two) and only share sensitive information with those who absolutely need that information to fulfil their roles responsibly. If you're communicating by email or text, make sure you have all recipients' permission to share their contact details: if not, when you send a group email, address it to yourself and put all other recipients into the "bcc"/blind copy line.

And finally, if someone asks you to stop contacting them or remove their details from your records, you must do so immediately.

Please remember that you must disclose any information you have if requested to do so by authorities such as the police, child welfare professionals or other statutory agencies.
