A Message from the Chair

The summer has passed and as we move into a new academic year we can look back on what was a magnificent victory and achievement for the Lionesses to bring home the European Championship.

As the trophy was lifted, it was worth noting that more than half the record-breaking Lionesses' squad started their careers playing schools' football.

Georgia Stanway, Alessia Russo and Hannah Hampton are 3 of our alumni who have played for our Under 15 International squad, representing us with pride during the Bob Docherty Tournament and related international friendly fixtures.

With this in mind it is fantastic to see the ESFA has recorded a record breaking number of entries into our girls' National Cup competitions for this season, providing football fixtures for over 29,000 girls. Not only that, it is worth noting that 67% of secondary

schools that enter our activity enter girls' teams in our National Competitions. It clearly shows that a large majority of those secondary schools that are committed to a schools' football programme, are creating inclusive opportunities for both boys and girls.

Whilst I am on the subject of 'record breaking' it is very heartening to see that we have more entries than ever before in our National Schools' Cup competitions. We have 7,227 entries overall with boys' entries up on last year to 5,297 and with girls' also up on last year to 1,930 entries. A very well done to all at the ESFA Headquarters in Stafford, with the Competitions Department and Marketing team working so hard to ensure the message really gets to you all.

It is a testament to you, the teachers around the country giving your time to provide football opportunities for our young people. I'm sure the students involved and their parents/carers would be the first to recognise the effort that goes in to ensure schools' football is played in a safe environment, that players are prepared through training sessions, kits are clean and the transport is ready to go allowing children to flourish in a sporting environment. It is for this I want to thank you as it is a real pleasure to see so many children enjoying the football that the ESFA has to offer.

Report of ESFA Council

Stuart Botham, Chair for 2022/23, welcomed Members to the first Council meeting of the season. A particular warm welcome was extended to new Council Members Matt Hughes (SW), Richy Alderson (N) and to Paul Jackson (SE). A minute's silence was held.

Council received their annual safeguarding briefing and re-signed their commitments to the safety and welfare of children. Members went on to discuss The FA's trials to remove heading from competitive fixtures in the U12 age group and agreed that a small group of tournaments/festivals would be arranged by Council Members to contribute to the trial. In small groups, Council went on to consider and review the role of Council and its Members and mandated the Chair, Vice Chair and CEO to refresh role descriptions accordingly. Further consideration to the roles and responsibilities would be given through the year. The importance of the role and its key commitments, including attendance and representation, were reiterated. Those Council Members present agreed which Council Member would support each CSFA, and those absent were to be contacted to finalise the list for publication.

Council received the "start of year" briefing from the CEO, which included a report demonstrating how FA KPIs had been met. In 21/22 thus securing continuation funding; the expectation of the Safeguarding 365 assessment, a list of partners and sponsors for the current season and confirmation that Pokémon were to be the official sponsors of the Inter-School Primary Competitions. The list of sponsors and partners is provided overleaf. Council noted the departure of fixed term staff in social media and national competitions, as well as the resignation of the Governance Manager. Replacement roles were being advertised.

The Rep Committee re-iterated its commitment to representative football outside of the National Competitions and agreed to a proposal from the Chair of Council that a national working group of Membership to address this issue should be developed. Clarification about the award of caps had been provided and dates for international fixtures agreed (U18 Boys: England v Wales 3rd March, Scotland v England 31st March, Rol v England 24th March and England v Northern Ireland 14th April, all with venues to be confirmed. Bob Docherty tournament 2nd-7th April, Scotland). Recruitment was underway for the U18 Boys' Assistant Team Manager, Physio and Team Welfare Officer, and for the U15 Girls' Team Welfare Officer, as well as the International Programme Manager to support administration of the programme. Interviews would conclude by the end of September.

The Football Governance Committee concentrated on further revisions to SCORY, taking account of additional feedback from Members, and agreed to further negotiate with ISFA to agree a set of rules for all schools. The main change was to allow "competitive" (rather than "developmental") football for U11s, meaning scores could be recorded and season-long activity run. Reference to the well-used but informal "mercy rule" was to be made. Submission to The FA for formal approval would follow and, in the meantime, Members were to move towards the published rules for this season, as far as was possible. The routine report on discipline was provided, with 344 yellow cards and 65 red cards recorded for season 21/22.

Council Report September 2022

The Football Development Committee received a draft strategy for engaging new players, in accordance with the principles of The FA contract, although specific targets had yet to be agreed with the FA. This strategy would include the continuation of disability festivals, the expansion of SEN provision, a new programme for "Hotshots" and an ESFA Development Fund open to Members. Longer term projects to reach new audiences, including visually impaired players and girls' "B" teams, amongst others were also approved. Members' and schools' appetite for futsal were to be sought via a survey.

The Competitions Committee noted that the Pokémon Primary Schools' Cup competitions were being formally launched during w/c 25th September and that a toolkit would be provided. The deadline for regional events would be 25 March 2023. There had been a record number of schools entering National Competitions this season, with 7,227 in total, 1,930 of which were girls' teams. The Champions' Cups had been approved to run and 125 boys' and 122 girls' teams had entered. There had been 25 suspensions from the Champions' Cups due to child welfare regulations not being met.

On top of matters reported elsewhere, Members heard from Trustees that, through careful financial management and the addition of new sponsors, the forecast deficit budget for 21/22 had been closed and a small profit secured. Insurance costs had doubled for this season, and utility bills had increased four-fold. Thanks were offered to the ESFA's Honorary Archivist, Allan Reed, who had made a very good start to organising and digitising ESFA historic records.

The Chair closed the meeting by thanking Members for their contribution and ongoing commitments to the ESFA.

Spotlight on: Andrea Chilton, Chief Executive Officer

The "Spotlight On" articles are intended to provide Members with an insight into Council and staff roles and the individuals fulfilling those responsibilities - and I have the pleasure of opening this season's staff series. As some of you will know, 22/23 sees the start of my 8th season in role, making the ESFA my longest standing employer and the CEO position my longest serving role. Prior to joining the ESFA back in Sept 2015, I'd worked in both the FE and HE sectors in the West and East Midlands as well as in East Anglia, and in the government's FE funding Quango's regional offices throughout the Midlands. My role immediately prior to my appointment at the ESFA was as Deputy Principal/Chief Executive in a large College with a £50million+ turnover and more than 20,000 enrolments in all subject areas other than agriculture, and for age groups ranging from 14 through to 100+. I was responsible for curriculum and quality across all 5 campuses where both



academic and vocational curricula were offered to full and part time students, distance learners, school excluders, HE students and apprentices. I was the Inspection Nominee at the College, having been the VP for Quality (and inspection nominee) in my previous outstanding College. I continue to be involved with FE as the quality improvement and inspection link Governor at my local college, which has just enjoyed an improved Grade 2 (good) inspection outcome. OfSTED inspection is the thing I miss most about FE – my last engagement saw me managing 14 inspectors covering 7 curriculum areas over 5 days across 5 campuses which, apart from the logistics, was another fantastic professional experience. Yes, I know, some of you may think that is a bit odd...

My role here at the ESFA has both similarities and differences to previous roles. The ESFA and the FE sector are both of course educational charities, and both require me to support and report to the Board. Both have significant day to day financial and safeguarding duties, and both require the ability to account to a regulator or funder, with "customers" at the heart of the service. However, here the similarities end: in FE, the year has a cycle which is, to a degree, predictable and there are teams of experts in every field to support the delivery of the business plan. At the ESFA, whilst we too operate on a season by season cycle, the work of the CEO can be varied and unpredictable. There's no "typical" week for me to describe to you, so here's some of the priorities to be addressed in September:

• The FA KPIs for the season: the budget is agreed, but KPIs remain in negotiation

- The checking of legal terms in new sponsorship contracts with Pokémon and for a further
 partner to support our primary age football, to make sure that the terms are as advantageous to
 the ESFA as possible, and that delivery plans are likely to satisfy and therefore retain the new
 partners.
- Redrafting staff employment contracts so that we remain up to date with current employment legislation.
- Proposing a structure to increase the efficiency and effectiveness of international operations
- Writing job descriptions for new posts, both paid and voluntary, and interviewing
- · Conducting staff appraisal and target setting
- Preparing for Council and Committees, including providing papers on U12 heading trials, the draft development fund plan and a proposal to support the development of referees
- Supporting the Finance Manager to finalise the accounts in preparation for the forthcoming audit
- Checking that we remain compliant with health and safety laws, including legionella testing, fire drills and other workplace safety assessments
- Preparing for mock job interviews for undergraduates at UCFB, as part of our commitment to their employability programme and our sponsorship contract with them
- Identifying a partner to support the ESFA with traditional media (TV, newspapers) management with a view to further improving our profile, and attracting new investors
- Reinvigorating our brand strategy work, with the support of a partner identified by our Independent Council Member, for the same reason
- Preparing for the forthcoming Safeguarding 365 assessment
- Supporting the Representative Committee's "International Working Group" to oversee the implementation of the international programme.

Occasionally, I even make a coffee! Although I'm pretty sure I haven't done that one yet this month.

So, busy times! I have always been, and continue to be, grateful to the ESFA's Council and its Committees for their instruction and guidance on schools' football, and to our Trustees who routinely plough through a business report of 100+ pages on the subject of running the charity, some of which is referenced above. But we are no busier, I am sure, that those of you who give hours and hours of your time, year after year, to make sure that children in your area enjoy the opportunity to play football. So, thank you all for your work and I hope you enjoy another tremendous season of schools' football.

- To enact competitions regulations as warranted by competition rules (e.g. appeals);
- To consult with and evaluate the experience of those participating in National Competitions;
- To identify and plan to mitigate risks or capitalise on opportunities within the Committee's remit;

ESFA National Finals - Team Manager Feedback

Following the 2021/22 National final events, the ESFA created 4 surveys designed specifically to capture the feedback of Team Managers within this season's National Finals.

- 1. Stoke City Schools' Cup Team Managers
- 2. Stoke City Rep Team Cup Team Managers
- 3. PlayStation F.C. Schools' Cup Team Managers
- 4. Primary Finals Team Managers

The ESFA received 49 responses to these surveys. 42 of the respondents were team managers from schools' teams. 7 respondents were Team Managers for Rep teams.

See below some highlights from the feedback that these respondents provided:

- 100% of team managers rated the quality of information provided by the ESFA as "Good or Very Good"
- 71% of team managers rated the quality of event planning as "very good" with the other 29% rating it as "good"
- Respondents were asked to rate West Bromwich Albion as a National Final venue on a 5 star rating scale (where 1 star was "Very Poor" and 5 stars was "Very Good"). The average rating was 4.7 stars.
- Respondents were asked to rate Stoke City FC as a National Final venue on a 5-star rating scale (where 1 star was "Very Poor" and 5 stars was "Very Good"). The average response was 4.85 stars
- 96% of respondents said they had no safeguarding concerns whilst at WBA with one
 respondent stating: "One of our players suffers anxiety/OCD Compulsions. He had
 to leave field of play during game to wash hands. He tried at one point to get out but
 was unable to and one of the ESFA staff notified our teacher so thank you for the
 support."
- 100% of respondents said they had no safeguarding concerns whilst at Stoke City FC.
- The overall rating given across all National Finals at WBA and Stoke City this season was 4.7 stars out of 5.
- The overall rating given for the National Primary Finals was 4.9 stars out of 5
